Consider oral and written testimony both for and against the initiation of amendments to the Capital Facilities Plan and Chapter 7 of the Comprehensive Plan and Chapter 13.650 and take action on whether or not to recommend the initiation to the Board of County Commissioners; and

Consider oral and written testimony both for and against the proposed updates and amendments to the Spokane County Capital Facilities Plan, Chapter 7 of the Comprehensive Plan, Chapter 13.650 of the Spokane County Application Review Procedures, and take action on whether or not to recommend the initiation to the Board of County Commissioners; and

Spokane County Code, Chapter 13.650, Application Review Procedures; Chapter 7 of the Comprehensive Plan, and the Capital Facilities Plan

Spokane County is considering amendments to the Capital Facilities Plan element of the comprehensive plan, Chapter 7 of the Spokane County Comprehensive Plan, and Chapter 13.650 of the Spokane County Code in response to litigation, specifically the Court of Appeals Decision on Case No. 38657-1-III issued on September 22, 2022. These components and development regulations must be amended in tandem to be consistent with one another.
