SBA Stands Ready to Assist Washington Businesses and Residents Affected by the Wildfires

SACRAMENTO, Calif. – Low-interest federal disaster loans are now available to Washington businesses and residents as a result of President Biden's major disaster declaration, U.S. Small Business Administration's <u>Administrator Isabella Casillas Guzman</u> announced.

The declaration covers Spokane County as a result of the wildfires that occurred Aug. 18 – 25, 2023.

"SBA's mission-driven team stands ready to help Washington's small businesses and residents impacted by the wildfires," said Administrator Guzman. "We're committed to providing federal disaster loans swiftly and efficiently, with a customer-centric approach to help businesses and communities recover and rebuild."

Businesses of all sizes and private nonprofit organizations may borrow up to \$2 million to repair or replace damaged or destroyed real estate, machinery and equipment, inventory and other business assets. SBA can also lend additional funds to businesses and homeowners to help with the cost of improvements to protect, prevent or minimize the same type of disaster damage from occurring in the future.

For small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations of any size, SBA offers Economic Injury Disaster Loans to help meet working capital needs caused by the disaster. Economic injury assistance is available to businesses regardless of any property damage.

Disaster loans up to \$500,000 are available to homeowners to repair or replace damaged or destroyed real estate. Homeowners and renters are eligible for up to \$100,000 to repair or replace damaged or destroyed personal property, including personal vehicles.

Interest rates can be as low as 4 percent for businesses, 2.375 percent for private nonprofit organizations and 2.5 percent for homeowners and renters with terms up to 30 years. Loan amounts and terms are set by SBA and are based on each applicant's financial condition.

Interest does not begin to accrue until 12 months from the date of the first disaster loan disbursement. SBA disaster loan repayment begins 12 months from the date of the first disbursement.

To be considered for all forms of disaster assistance, survivors must first contact the Federal Emergency Management Agency at <u>www.disasterassistance.gov</u>. As soon as Federal-State Disaster

Recovery Centers open throughout the affected area, SBA will provide one-on-one assistance to disaster loan applicants. Additional information and details on the location of disaster recovery centers is available by calling the SBA Customer Service Center at (800) 659-2955.
